Internship individual supervisor evaluations indicate 100% of students received a score of 3 or above out of 5, which indicates they have demonstrated the required skills applying the PLO 2 into practice during their internship experience. 86.36% of students scored within 1 SD of the national norm on section C2 on the nation exit exam, indicating they mastered this PLO.	Although the majority of students are mastering this PLO, program faculty will revise course material for COUN 509. In previous semesters, the instructor utilized one textbook for assigned readings, which potentially limited students' views of the topic area. For future semesters, the instructor will include three types of readings/materials for course including academic peer-reviewed articles, first-person narratives, and student selected materials (e.g., TED talks, blog posts) related to the topic. In addition, the instructor will review the exam and consider edits to be more in line with national standardized exams.

Program faculty will consider making the final exam mandatory since it is included as a PLO measure. Based on scores for Leader Plan and exit exam C6 section, the majority of students are mastering the material for this PLO. Making the final exam mandatory may increase the percentage of students who pass this section in the national exit exam to 100%.
