## Boise State University Seven Arrows Powwow Craft Vendor Regulations and Guidelines

*Please Read Thoroughly*

1. The vendor agrees to defend at their own cost and hold harmless Boise State University and the Indigenous Idaho Alliance, its members, and agents, from all liability and damages resulting from the operations of their space.
2. The vendor is responsible for obtaining and paying for all state and local permits and licenses pertaining to their operation at this event.
3. To ensure space, vendor application, a registration fee of \$125 and any other additional fees must be received by **March 24, 2023**. Any applications submitted after the deadline will be charged a \$50.00 late fee.
4. All vendor space will be assigned by the Seven Arrows Powwow Committee and your name/business will be printed in the space assigned. Please **DO NOT** change spaces.
5. Volunteers will be on hand to assist, but there is no guarantee they will be able to do it on your time schedule. We also ask to be patient with volunteers and resources provided by the university.
6. Security will be on patrol on campus and in the arena, but vendors are encouraged to secure their merchandise at the end of each day. Boise State University, Indigenous Idaho Alliance, its members, and its agents will not be responsible for any items left or lost.
7. In the event of the powwow being hosted outdoors, **NO VEHICLES** are permitted to be on university lawns and landscaping. Please do not arrive before 8am as no one will be there until 8am. Any vehicles on lawns or landscaping will be subject to university parking regulations are subject to towing and/or fees. Parking will be free and provided at the West Stadium parking lot.
8. Boise State University and the Intertribal Native Council reserve the right to prohibit the display or sale of all items deemed inappropriate by them.
9. Please be ready to sell by 11:30am-9pm on Saturday, April 15, 2023, and 11:30am-4pm on Sunday, April 16, 2023. We request that you do not leave earlier as a courtesy to attendees. If you need to leave earlier, please contact the Powwow Committee immediately so we can accommodate the request.

*Any vendor found disregarding any policy will be asked to leave and their fees will not be refunded.*
